### **1. CALL TO ORDER**

The meeting was called to order at 9:05 a.m.  
A quorum was present.

### **2. DISCLOSURE OF PECUNIARY INTEREST & GENERAL NATURE THEREOF**

### **4. APPROVAL OF MINUTES**

- i) **Minutes – September 12<sup>th</sup>, 2014.**

The minutes of the 200<sup>th</sup> Anniversary Working Group Meeting held on September 12<sup>th</sup>, 2014 were approved as circulated.

### **5. DELEGATIONS & PRESENTATIONS**

None.

### **6. BUSINESS**

- i) **Invitation to Schools.**

David Taylor commented on the example of the letter (attached to the agenda) from Drummond/North Elmsley's anniversary committee to the public schools in their municipality, inviting their participation in studies related to the anniversary. A number of ideas and formats were discussed, including a travelling play, short skits, and student-developed multi-media presentations. Susan Freeman will contact the principal of Glen Tay Public School. It was suggested that an invitation to the Perth and District Collegiate Institute and St. John's High School should come from the Joint 200<sup>th</sup> Anniversary Committee to reflect that students come from the townships as well as from Perth. The Working Group would offer access to resources (including the anniversary book) for incorporating settlement history into the curriculum. A decision was not made regarding a submitted idea for a travelling play that involves students.

- ii) **Ontario's Highlands Tourism Organization Conference.**

Noelle Reeve announced the Ontario's Highlands Tourism Organization Conference to be held October 27-28, 2014 at the Pinestone Resort, Haliburton. Since there will be no attendees from Tay Valley or the Joint 200<sup>th</sup> Anniversary Committee, David Taylor will ask Marie White from Lanark County Economic Development to represent the rural and anniversary focus of this Working Group.

iii) **Artist Project.**

Noelle Reeve shared a query from a Merrickville artist to paint “a series of artworks which would give a visual depiction of the human element of Perth’s past events – what it would have felt like to be in the moment of historical happenings.” The artist is looking for a community partner to share in applying for a grant from the Ontario Arts Council. The Working Group decided that, while an interesting idea, it is late to try to take it on. The historical society received the same enquiry; they informed the artist that they cannot take an active role, and suggested that the idea be presented to the Joint 200<sup>th</sup> Anniversary Committee.

iv) **200<sup>th</sup> Anniversary Tourism Package.**

No discussion.

v) **Lanark Wild Food Club.**

No discussion.

vi) **Promotion & Marketing - Proposed Joint Activities.**

David Taylor reported on two of the working groups under the Joint 200<sup>th</sup> Anniversary Committee. The Promotions working group is planning joint activities that focus on anniversary awareness and homecoming. There will be advertisements in the Chamber of Commerce tourism guides for Perth and Carleton Place in 2015, and a 4-page insert in the 2016 Perth guide, amongst other activities. There are two mailings planned to encourage people to participate in homecoming travel, the first mailing in January 2015, and a follow-up a few months later.

The Funding working group is preparing an application to Canadian Heritage for funding for anniversary events, with input from the four municipalities. The Tay Valley event leads will be contacted by David Taylor to provide details on to include in the grant application.

## **7. UPDATES**

i) **Joint 200<sup>th</sup> Anniversary Committee.**

David Taylor confirmed that the next meeting of the Joint 200<sup>th</sup> Anniversary Committee is November 12. Agenda items include the review and approval of the funding application; and decision on proceeding with a Request for Quotes regarding branding.

ii) **Legacy Farms.**

Seven applications have been received to date. Working Group Members are asked to remind possible candidates to submit applications by December 19.

iii) **Legacy Cottages.**

Kay Rogers worked with Karen Hunt of the Lake Networking Group to send invitation letters to lake associations. The replies indicate that, because many of our lakes cross township boundaries, this might be better as a Canada 150<sup>th</sup> anniversary initiative. This item will be dropped from this Working Group's agenda.

iv) **Legacy Trees.**

The "Maberly tree" was chosen as a first Legacy Tree for promoting public participation in the nomination process. A plaque is being designed. As this item may also be carried forward to Canada 150<sup>th</sup> anniversary initiatives, it would be appropriate to use the Tay Valley Township logo rather than the anniversary logo.

v) **Lanark Greening Apple.**

Some Working Group Members visited the McFarlane apple tree at Drummond 8<sup>th</sup> Line, and is liaising with a gene bank to determine whether it matches.

vi) **Program Funding.**

In addition to the Canadian Heritage grant application covered above under 6.vi, Noelle Reeve will prepare an application for Trillium funding.

vii) **Anniversary Book.**

Kay Rogers announced that a reception will be held on Saturday, November 22, 2-4 p.m., for the people who have submitted articles or have been interviewed (more than 40), as well as for the new councillors and media representatives. The reception will provide an opportunity to thank the contributors, give each a DVD of their interview, take a group photo (to be included in the book), and promote upcoming anniversary events. The event budget is about \$200 for catering, to be taken from the reserve for the Working Group.

Noelle Reeve left the meeting for the rest of this item's discussion.

A local broadcasting student is assisting with converting the interview recordings to DVD format. There are expenses for DVDs, labels and printing.

xi) **Whiskey Tasting.**

A Request for Expressions of Interest for sommeliers and venues for the Whiskey tastings will be issued shortly by The Friends of Murphys Point.

xii) **Chart of Events & Projects Review.**

David Taylor is updating the Chart of Events regularly, and it is available for view by Working Group Members on Dropbox (or may be requested from him by email). Information updates are requested.

xiii) **Settlers Trail.**

Signage is planned for prominent locations. The project design and pricing is being developed, as well as a description to include in the grant application to Canadian Heritage.

xiv) **EcoPerth Tree Donation.**

David Taylor confirmed that EcoPerth has offered two types of donations to the anniversary events: (1) Cuttings for the Lanark Greening Apple; and (2) two hundred trees to be given to each municipality. A future meeting will discuss how the cuttings and trees might be distributed.
