1. CALL TO ORDER

The meeting was called to order at 6:31 p.m. A quorum was present.

2. AMENDMENTS/APPROVAL OF AGENDA

6. PRIORITY ISSUES

i) Report #PD-2017-14 – Final Report on 200th Anniversary and Legacy Projects.

Dog Tags

The Committee discussed the possibility of having dog owners register once and only contact the Township for a replacement tag or if they no longer have the animal. In the meantime the staff recommendation with regards to fees will proceed.

Recommendation to Council:

"THAT, Staff research and bring back a report outlining the legislative requirements regarding dog tags, as well as alternative options for registering dogs for Council's consideration."

Cash in lieu of Parkland

The Committee determined that the distinction should remain between rural severances versus waterfront severances as most municipalities charge the legislated 5% in lieu instead of a flat fee. The Committee agreed that the fees should be \$200 and \$400 respectively. The Committee suggested that the fees for cash in lieu of parkland go up in smaller increments on a more frequent basis.

iii) Report #CAO-2017-08 - Review of Private Road Grant Program.

Larry Donaldson, Chief Administrative Officer.

The Chief Administrative Officer gave a presentation – *attached*, *page 12*.

Wayne Phillips, resident on the Big Rideau North Shore Road (BRNSR) was asked by the BRNSR Association to speak on their behalf:

- the road is unique; it is not like all the other private roads; it is 9 km in length; open ended at both ends; it is not a laneway, there are 70 dwellings on the road and an additional 30 on the private roads that come off of this road
- the Lanark County Maple Routes map shows the road as a township road
- the Rideau Trail runs through and on the road, large groups are accessing the road
- the insurance liability if there is ever an accident on the road, they will sue everyone on the road and also sue the municipality
- would appreciate consideration at a re-look at the recommendations to the last Council
- proposing that a grant only to certain roads be provided (ex. those with established associations, more than 40 dwellings, more than 5 km in length, must have at least 2 exits) that would minimize the Township's involvement, leaving maybe 25 private roads to provide a subsidy to

The Committee discussed whether or not the position was required. Some Members of Council felt that the Township is over staffed as Lanark Highlands and Drummond North Elmsley have less staff and therefore there is capacity in some positions since those other municipalities seem to meeting legislative requirements with fewer staff.

The Chief Administrative Officer and Clerk informed the Committee that there are many factors to consider when looking at staffing levels, including services that a municipality offers and the level of service set by Council. The current vacancy is as a result of a contract staff member leaving the employment of the Township and the position needs to be filled until the end of August when the permanent incumbent returns to that position.

As previously requested by Council, the Clerk will be bringing a subsequent report back to Council in August regarding staffing requirements in the Clerk's Department.

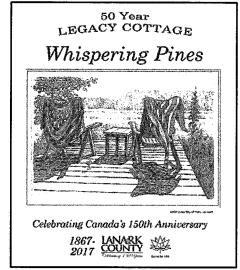

Review of Private Road Grant Program

- May 2016, Council asked staff to prepare a report on private road grants including researching the previous reports on the subject.
- > Committee struck in 2006 to evaluate the idea and make recommendations to Council.
- Detailed review in the 2006-2007 period, including public meeting and survey.



- > Committee made three recommendations
 - 1. Establish a a \$40,000 grant for private roads;
 - 2. Consider a reduction in standards for the assumption of private roads;
 - 3. Explore compensation for damage to private roads caused by contractors.



Review of Private Road Grant Program

- Council did not approve any of the above three recommendations and therefore no policy was adopted to begin a grant for private roads, the policy for the assumption of private roads stayed the same and a policy dealing with compensation for damage to private roads was not adopted.
- > The situation has remained ever since



- Question: What, if anything is different today than when last reviewed ten years ago?
- > Answer: Not much is different. In fact the issues are still relevant issues today as a result there is no compelling reason for the Township to change its position at this time.



Review of Private Road Grant Program

- > There are municipalities (Beckwith Township is the only one in Lanark County) that do provide grants for private roads with most outlining the reasons as follows:
 - Improved access for emergency vehicles
 - An economic development initiative
 - Increased recognition of the taxes generated from properties in private roads – most of which are waterfront.



> Conclusion: Based on the review, staff is recommending no change to existing policy.
