#### 1. CALL TO ORDER

The meeting was called to order at 2:05 p.m. A quorum was present.

#### i) Policing Contract.

Detachment Commander.

a) Lanark County OPP – 3<sup>rd</sup> Quarter Report.

The Board reviewed and discussed the reports.

The Board noted the significant decrease in pro-active cruiser patrol.

The Staff Sargeant informed the Board that just like every other organization the OPP are also seeing staffing shortages. The other impact is that officers do not have time to do proactive patrol but are rather going from call to call. The Detachment has the same staffing levels, but the call volume has increased significantly. This is not specific to Lanark County; it is happening Province wide.

The Board understands the situation but would still like to see an increase in proactive patrol hours in the future and will leave it with the OPP to address how to accomplish this.

#### ii) Detachment Commander Update.

Detachment Commander.

The Staff Sargeant did not have a report from the Detachment Commander to share with the Board.

## iii) Status of Township Request for Enforcement.

- Harper Road
- Glen Tay Road

This year a portion of Harper Road was reconstructed and speed limits reduced in certain sections. The Township then conducted a speed assessment which showed that most vehicles were travelling over the 85<sup>th</sup> percentile. As a result, the CAO/Clerk requested the OPP a little over a month ago to conduct speed enforcement at this location.

A speed assessment was also conducted on the portion of Harper Road where the speed limit is 40 km and where a couple of years ago traffic calming measures were implemented. Again, the results showed that most vehicles were travelling over the 85<sup>th</sup> percentile. As a result, the CAO/Clerk requested the OPP a little over a month ago to conduct speed enforcement at this location.

The Staff Sargeant was not aware of the requests, so the CAO/Clerk committed to resending the emails with the request for enforcement.

#### iv) **Detachment Board.**

Appointment of Council Representative

A report will be coming forward to the December Committee of the Whole meeting recommending that the Reeve be appointed as the Council Representative to the new Detachment Board.

The current Board agreed as the Reeve currently service on the Tay Valley Police Services Board and the continuity would be beneficial, along with the decisions that will need to be made on behalf of the Township with regards to how the new Detachment Board will be set up.

The next step in the transition to the new Detachment Board will be for the Council Reps and the CAO's from each of the municipalities to meet to develop a terms of reference for the new Detachment Board so that a Community Representative can be advertised for and appointed in February.

The current Municipal Appointee, Neil Fennell will be ineligible to be on the Detachment Board as he is a former OPP officer.

The Reeve, CAO/Clerk and hopefully the Community Rep will attend the two-day training session at the end of February.

There are still many unknowns, such as what is going to happen with the current Provincial Appointees? Currently Tay Valley's Provincial Appointee has a term until the end of June 2024.

The Board agreed that the Reeve should initiate conversation with the Chair of the Lanark County Association of Police Service Boards to get a transition meeting scheduled before the end of the year so that some decisions will have been made before the January 17<sup>th</sup> Association meeting.




#### Report to Tay Valley

#### Note


It should be noted that the Covid-19 Epidemic has had a significant influence on offences as well as traffic. Due to various restrictions during the Epidemic, there was considerably less travel as well due to "Lock Down" measures. These various responses appear to have had a particular impact on property and driving related offences in a downward fashion. The Pandemic was declared the 11<sup>th</sup> of March 2020 and the impacts were obvious for 2020-2021 and to a lesser degree for 2022 offence related incidents. This is particularly relevant when looking at the benchmark occurrences for this report.


While 2022 did see a start to return to normal it is anticipated that 2023 will see a true return to numbers, similar to the pre-pandemic 5-year average for both offences and traffic related occurrences. At the request of Inspector Padiachi I have conducted a 5-year review of calls for service (01 Jan2019 – 31 Dec 2023) by type and clearance rate as requested. The request included an overview of all Lanark County as well as each municipality within the Lanark County Detachment area.

Utilizing IBM Planning and Analytics I conducted data extractions for the specified items using the Niche RMS Offence Level Cube.

All incident counts were harvested by "Actual" within Niche RMS. Clearance Rates are based on "Actual" within Niche RMS

The "Motor Vehicle Collision" Data is drawn from RMS and includes both reportable and non-reportable as defined by the Highway Traffic Act. This figure will be different from the "Reportable" Collisions reported quarterly to the municipalities.


The "All Lanark County" is the sum of all calls within Lanark County by Municipality



5 YEAR Theft Under \$5000.00 ALL LANARK COUNTY 5 YEAR AVERAGE








